You may also view Customs Info Database. Angola eliminated the Consumption Tax and replaced it with a Value Added Tax (VAT). This VAT was implemented on October 1st, 2019, and has a tax rate of 14 percent. VAT will be applied during the first 18 months to large taxpayers (companies).
